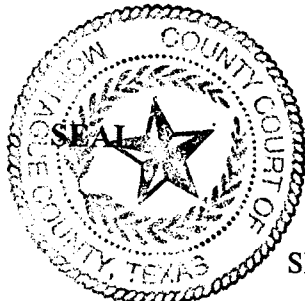
BOBBIE BRASHEAR JR, LANCE BRASHEAR, JAN BROWNING filed in the COUNTY
