#14-262A-Motion by Commissioner Langford and seconded by Commissioner Murphey to remove the \$400,000 from the proposed budget (8-11-14 meeting order # 14-258C) and use the 7.9% tax increase to cover that.

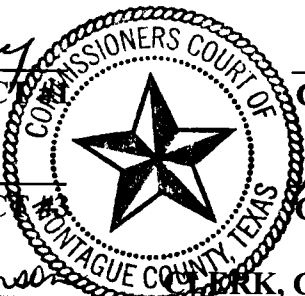

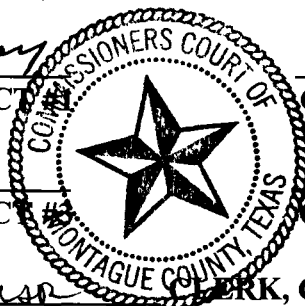
