Subject: Montague County Jail, TX – MTI Control System Upgrade

Montgomery Technology Systems, LLC is pleased to provide a quote for all necessary material and labor for a complete and fully functional control system for the above referenced project. MTS is proposing to provide a Montgomery Technology, Inc. (MTI) control system. MTI has been in business for over 27 years and has completed over 1800 installations in the detention market. This quote is based on original project documents.

Base Scope of Work

MTS will provide and install a MTI Firefly control system. MTS will replace the existing head end equipment with a MTI 91695 Embedded Controller. MTS will provide a new digital intercom amplifier to replace the existing intercom amplifier.

MTS will provide and install one (1) new control station to replace the existing graphic panel. The new control station will have similar functionality of the system. A control station includes a HP EliteDesk 800 G1 Small Form Factor computer, 32” touchscreen monitor, a BR1300 UPS and microphone for intercommunications. MTS will pull Cat6 cabling between control station and associated equipment room. MTS will provide a new HP network switch in the local equipment room.

As an option, MTS will provide a 32” LCD monitor in lieu of a 32” touchscreen monitor.

MTS will provide new UPSs for all head end equipment and control stations. Liebert On-line UPS systems will be utilized. The UPS system will be sized to provide fifteen (15) minutes of run time for all systems included in this quote.

MTS will reuse all existing field devices except where otherwise noted. MTS will assist in troubleshooting problems with existing field devices. Once an existing field device is found to be defective, it will be the facility’s responsibility to repair or replace the existing device.

Pricing

MTS is pleased to provide the above scope of work for a **total of \$22,650.**

Warranty
