Describe the steps taken to ensure that the minimum standards of health and sanitation will be maintained during the gathering:

RWP has installed sixteen (16) permanent showering units, 150 Port-A-Potties have been installed throughout the Park, with A-1 Porta Privy, Inc., 1917 N. I-35, Gainesville, Texas 76240, telephone (940) 668-6511 is contracted to perform regular pumping water supply

RWP has three different five man crews picking up and disposing of trash from 6 a.m. to midnight throughout the course of the event and after the event is over until the park is cleared of all trash and debris.

Describe the steps taken to ensure the physical health/safety of the persons attending:

In preparation for adequate medical and nursing care RWP has privately contracted with Sacred Cross Ambulance and Emergency Services to provide 24 hour on site emergency medical care during the duration of the Event (from "Open" to "Close").

The Saint Jo Volunteer Fire Department/EMS medical and rescue staff, Montague Sheriff's Department Deputies and Lone Star Protection and Security employees are also present.

Public Safety Compliance:

Following the minimum standards of the Texas Administrative Code, Title 37, Chapter 1, Subchapter L, Sections 1.161-1.169, NFPA 1, JFPA 101. Printed copy of Administrative Code sections are available upon request at the County Judge's office.

Describe how attendance will be limited to the maximum number stated in the event description above: A limited number of tickets are controlled (for sale) to ensure that the maximum capacity will not be exceeded.

Describe the preparations you will take to provide traffic control:

In an effort to prepare for traffic control, RWP has trained staff, Montague County Sheriff's Department and Lone Star Protection and Security, LLC contracted to direct parking and handle traffic control from the Farm to Market. The location is NOT located on a major thorough fare linking any metropolitan area or city.

Private entrances/exits have been added to the Park for the use of some spectators, staff, law enforcement and medical staff to ensure that there are no delays in the event of an emergency and to reduce the traffic from the general entrance/exits.

Directional Signs have been added in order to direct people to specific areas of the Park in an effort to keep the flow of traffic controlled and in the proper direction. Maps of the park with noted landmarks are provided to each person upon entry into the park.

Describe the steps you will take to ensure that the mass gathering will be conducted in an orderly manner:

The Montague and surrounding counties Sheriff's Departments also have contracted various Deputies to be on duty as security to assist with the traffic flow if necessary and to patrol the park.

Texas Department of Public Safety is notified and provided all information on the Event. Multiple Electronic Road Signs are rented by RWP from Texas Department of Public Safety effort to assist with and direct traffic in the appropriate direction and discourage drinking and driving.

Lone Star Protection and Security, LLC have been contracted to be on duty as security to assist with the traffic flow if necessary and to patrol the park and enforce any rules and regulations.

Speed Limit signs have been posted and will be enforced by the security and staff, the Maximum Speed Limit is 10 mph. An outside consulting agency that is contracted to perform safety officer duties to be on call 24/7 during the event. RWP has a Safety Committee who has regular meetings to discuss various types of procedures and implementation of same to ensure the safety of all patrons in the park.

Describe the preparations you will take to supervise minors who may attend the mass gathering: No one under the age of 18 will be admitted to the Event.

Identify the location on the grounds where the promotor or a representative will be available at all times during the event: Gate 1 Office.

Ms. Stout,

I have reviewed the paperwork and conducted a site visit of the Rednecks With Paychecks location. Listed below are my recommendations for the event. I have been instructed by my supervisor that we do not sign off on any paperwork. He suggested that you forward my email comments to the County Sheriff and have him sign off on the event paperwork. If the Judge has any questions please have him call me at any time.

The State Fire Marshal's Office has conducted a site visit of the Rednecks With Paychecks event location prior to the date of the event and have the following recommendations.

- 1. Any commercial food vending trucks that are grilling or deep frying or producing grease laden vapors shall have a UL-300 wet chemical fire suppression installed. The system shall have a current inspection tag from a licensed fire protection company dated within the last six months indicating the system passed inspection and is operational.
- 2. All portable grills or fryers shall have a Class K portable fire extinguisher for each unit. All portable units shall be located at least 20 foot from the combustible wood building fronts and or sides.
- 3. All access roads /fire lanes RV camping roads shall be maintained at least 20 foot wide at all times.
- 4. The VIP band stage mezzanine area shall be restricted to a total occupancy of 49 persons unless a second egress stairs is installed remotely located from the existing stairs.
- 5. Any fenced in areas around band stages shall have the following number of egress areas, less than 6000 two means of egress, more than 6000 three egress areas, more than 9000 four egress areas. All means of egress shall be widely separated from each other.
- 6. All office buildings, ticket sales offices, merchandise sales buildings and stage areas shall have class A, B, C portable fire extinguishers that are fully charged and shall have a current annual inspection tag from a licensed fire protection company. Minimum extinguisher size shall be 10 lbs.

NOTES:

- 1. The event coordinator stated there will not be any large tents, cooking tents or assembly tents set up for the event.
 - 2. There will not be any pyrotechnics during the event.
 - 3. The Fire Department is on location 24 hours a day for the entire event.

The above recommendations are based on information provided by the event staff and the site visit. The State Fire Marshal's Office is not responsible for changes to the event setup. No onsite inspection will be conducted by the State Fire Marshal's office immediately prior to or during the event.
