KNOW ALL MEN BY THESE PRESENTS that the BOWIE INDEPENDENT SCHOOL DISTRICT, TRUSTEE, for itself and on behalf of the CITY OF SUNSET and THE MONTAGUE COUNTY, acting by and through its duly elected officials by resolution duly proposed and adopted in the manner required by law ("GRANTORS") as authorized by Section 34.05, Texas Property Tax Code, for and in consideration of the sum of TWO THOUSAND DOLLARS AND NO/100 (\$2,000.00), in hand paid by BRANDY BARKER ("GRANTEE") the receipt of which is hereby acknowledged and confessed, has conveyed and quitclaimed and by these presents do convey and quitclaim unto said grantee all right, title and interest of the BOWIE INDEPENDENT SCHOOL DISTRICT, the CITY OF SUNSET and MONTAGUE COUNTY in the property herein conveyed, acquired by tax foreclosure sale heretofore held in Cause No. 2011-0145M-CV, styled City of Sunset vs. Steve Merle Carsley, said property being described as:

0.880 Acres, more or less, Part of Lot 3, Block 32, Original Town of Sunset, Montague County, Texas, as more particularly described in a deed recorded in the office of the County Clerk filed in Volume 455 at Page 353 of the Official Public Records of Montague County, Texas;

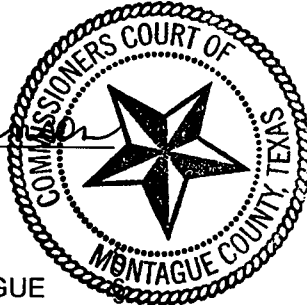

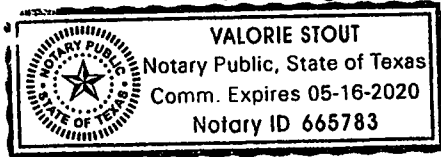
