A RESOLUTION REGARDING A FINANCING AGREEMENT FOR THE PURPOSE OF PROCURING "VEHICLES AND RELATED EQUIPMENT."

WHEREAS, Montague County desires to enter into a certain Financing Agreement, by and between Government Capital Corporation and the Montague County, for the purpose of financing "Vehicles and Related Equipment." Montague County desires to designate this Agreement as a "qualified tax exempt obligation" of Montague County for the purposes of Section 265 (b) (3) of the Internal Revenue Code of 1986, as amended. Montague County desires to designate the County Judge as an authorized signer of the Agreement.

NOW THEREFORE, BE IT RESOLVED BY THE COURT OF MONTAGUE COUNTY:

<u>Section 1.</u> That the Montague County enters into a Financing Agreement with Government Capital Corporation for the purpose of procuring "Vehicles and Related Equipment."

<u>Section 2.</u> That the Financing Agreement, by and between the Montague County and Government Capital Corporation is designated by Montague County as a "qualified tax exempt obligation" for the purposes of Section 265 (b) (3) of the Internal Revenue Code of 1986, as amended.

<u>Section 3.</u> That Montague County designates the County Judge as an authorized signer of the Financing Agreement, by and between Montague County and Government Capital Corporation.
