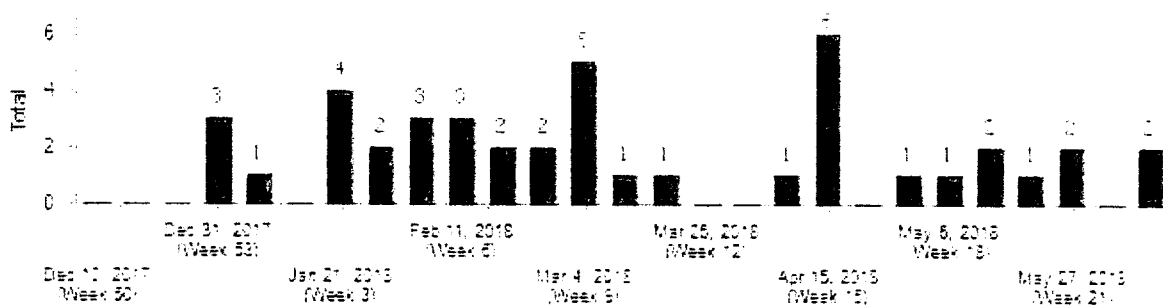

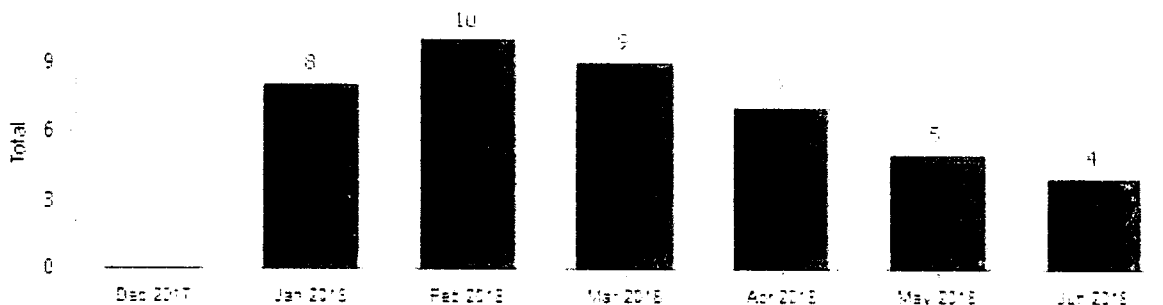
Deployments By Day Of Week

Deployments By Month



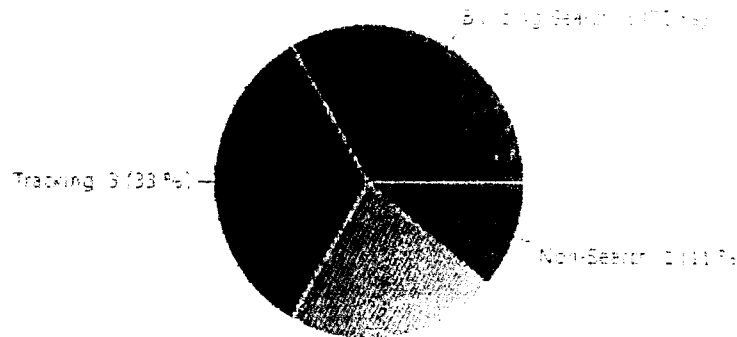

Patrol Types

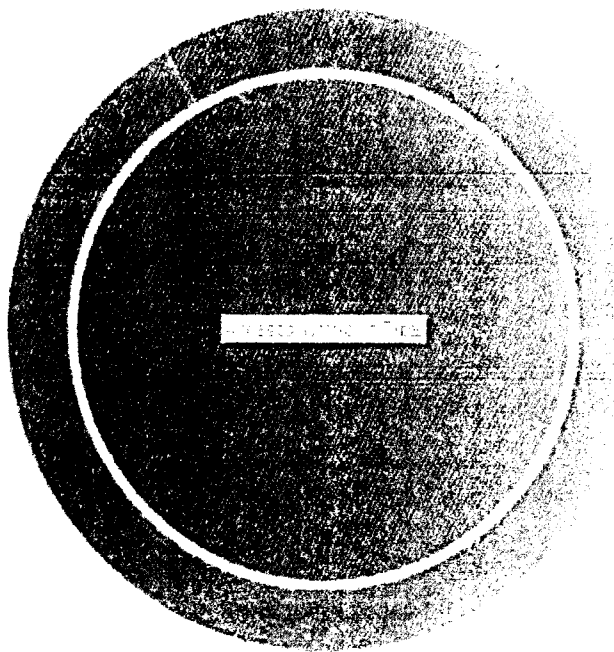

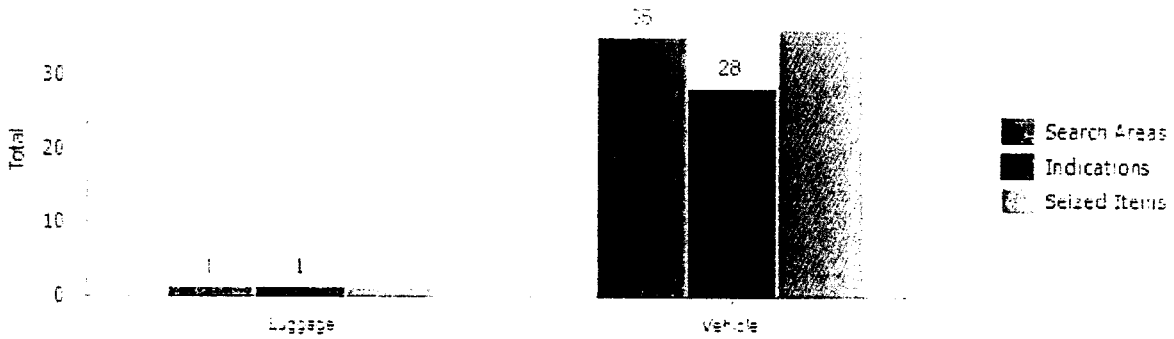
