A RESOLUTION OF THE MONTAGUE COUNTY TRUSTEE AUTHORIZING THE GLERK SHERIFF OF MONTAGUE COUNTY TO RESELL A TAX KORECLOSED PROPERTY X STRUCK OFF TO THE MONTAGUE COUNTY TRUSTEE, BY PUBLIC SALE AS AUTHORIZED BY SECTION 34.05 OF THE TEXAS PROPERTY TAX CODE

WHEREAS, MONTAGUE COUNTY TRUSTEE, for itself and the use and benefit of Montague County has acquired title to a certain tract of real estate at a Tax Sale held on May 3, 2016 in Suit #2011-0340M-CV MONTAGUE COUNTY, ET AL VS RODNEY NELSON, ET AL

A sale under this section, extinguishes all liens foreclosed by the judgment as well as the liens for post-judgment taxes, with the exception of the prorated tax for the current year.
