KNOW ALL MEN BY THESE PRESENTS that the CITY OF BOWIE, TRUSTEE, the BOWIE INDEPENDENT SCHOOL DISTRICT, and MONTAGUE COUNTY, acting by and through its duly elected officials by resolution duly proposed and adopted in the manner required by law ("GRANTORS") as authorized by Section 34.05, Texas Property Tax Code, for and in consideration of the sum of ONE THOUSAND DOLLARS AND NO/100 (\$1,000.00), in hand paid by RICHARD PIETILA ("GRANTEE") the receipt of which is hereby acknowledged and confessed, has conveyed and quitclaimed and by these presents do convey and quitclaim unto said grantee, subject to the reservations and exceptions hereinafter made and with the restrictions and upon the covenants below stated, all right, title and interest of the CITY OF BOWIE, BOWIE INDEPENDENT SCHOOL DISTRICT, and MONTAGUE COUNTY in the property herein conveyed, acquired by tax foreclosure sale heretofore held in Cause No. 2017-0016M-CV, styled BOWIE INDEPENDENT SCHOOL DISTRICT VS.MARIO S CORREA, said property being described as:

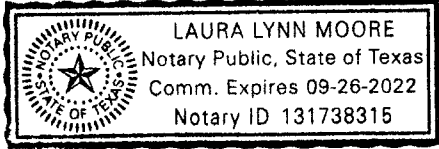
