Missy with the Sheriff's office contacted me this afternoon explaining a 9-1-1 call came from a wireline phone at 108 Bonham St. Bonham St limits of Nocona. There was some confusion on the response as the telephone company had assigned that telephone number to be in the cc Bonham St is also located in Belcherville. There are currently no structures on Bonham St in Belcherville. I would recommend naming the Be as Bonham Rd. We are working to correct the error with the telephone company.

It is important to make these corrections as we move closer to Next Generation 9-1-1 call routing. There will be more of these changes I am : occurring in other jurisdictions as well as we work to clean up our structure and roads data.
