Judge Benton,

Nocona Lakes Estates VFD is dissolved as of August 31, 2020. Frontier Shores VFD no longer exists and hasn't for many years. To more accurately reflect the actual area covered by the County's fire and rescue departments, the Montague County Firefighters Association requests that both of these agencies be removed from the Official Fire and Rescue District Map of Montague County by official action of the Commissioners Court. Further we request that the Nocona Lake Estates coverage area be included in Nocona Rural's area and the Frontier Shores coverage area be included in Bowie Rural's area.
