TO RECEIVE PUBLIC COMMENT ON REDISTRICTING OF COUNTY ELECTION, JUSTICE OF THE PEACE AND COMMISSIONER'S COURT PRECINCTS. AFTER THE PUBLIC HEARING, THE COMMISSIONER'S COURT WILL TAKE UP FOR CONSIDERATION AND TO TAKE POSSIBLE ACTION REGARDING ONE OR MORE ALTERNATIVE PLANS FOR THE REDISTRICTING OF COUNTY COMMISSIONER'S COURT PRECINCTS.
