Chief Deputy Jack Lawson, spoke on behalf of needing a better In-House Fingerprinting System for the Sheriff's Office. Mr. Lawson gave two separate options for the Silver System. Montague County could either pay outright \$25,000.00 with a \$4500.00 yearly maintenance fee (a total of \$29,500.00 initially) or have a 3- year contract and a yearly maintenance fee of \$7500.00.
