We are pleased to announce that the Montague County Historical Commission (CHC) has earned a Distinguished Service Award (DSA) for the 2021 year of service. While all CHC efforts are valued, DSAs acknowledge above average CHC performance based on a statewide analysis of CHC annual report documentation. Our agency received 193 CHC reports for 2021 and approved 82 awards, quite an accomplishment given that the pandemic limited public programming for all CHCs.

To honor appointees' contributions, we ask that you acknowledge the award publicly as soon as possible. Typically, we recommend presenting the enclosed DSA certificate to CHC appointees during a formal meeting of the commissioners court. If an in-person ceremony is not feasible, please consider implementing other ideas listed on the enclosed flyer to recognize your CHC's outstanding service to the county.

2021 CHC Annual Report Summary

County Historical Commission (CHC) Performance Highlights

The Texas Historical Commission received reports from 193 County Historical Commissions (CHC) for the 2021 year of service. Below are primary reporting statistics that demonstrate the breadth and value of CHC services.

- 284,046 CHC volunteer hours represents work of 136 employees and has a monetary value of \$8,507,177.*
- Return on investment-for every \$1 counties invested in CHCs, \$8.19 worth of service was returned by CHCs.
- CHCs supplemented county money with \$353,167 from grants, donations, and fundraisers.
